This Memorandum of Understanding (MoU) is entered into on this 21st day of May, 2014 by and between Mangaldai College, Mangaldai, Darrang, Assam – hereinafter called "COLLEGE" or "First Party" which expression shall include its successors and permitted assignees – situated at Mangaldai under the District of Darrang, Assam, a college permanently affiliated to the University of Gauhati and recognised by the University Grant Commission (UGC) with UGC 2(f) and 12(b) – represented by its Principal, Dr. Khagendra Kumar Nath.

And

Tahbildar Clinical Laboratory or also known as TCL, Santipara, Mangaldai, Darrang hereinafter called "PARTNER INDUSTRY" or "Second Party" which expression shall include its successors and permitted assignees – having its registered office at Mangaldai, Ward No. 1 Darrang, Assam – represented by its Proprietor, Dr. P. K. Tahbildar, MD Pathologist (The First Party and Second Party are hereinafter jointly referred to as "Parties" and individually as "Party")

WHEREAS:

The College is engaged in education, training, research, publications, organization with a view to strengthening the cause of formal, employment centric, technological and practical education.

2. The First Party & Second Party believe that collaboration and cooperation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.

3. Mangaldai College, the First Party wishes to enhance its services through B.Voc. Programme in Medical Lab & Molecular Diagnostic Technology Courses as per UGC Guidelines to prepare its students for job employment and self-employment; and, for successfully imparting the course, the College wishes to utilise the expertise, linkage and proficiency of Tahbildar Clinical Laboratory (TCL), Mangaldai.

4. Tahbildar Clinical Laboratory (TCL), Mangaldai, by considering the importance and possible outcome of the aforesaid programme, expresses its desire to get associated and provide support for the cause.

5. The Parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.

6. Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutual interests.

7. Tahbildar Clinical Laboratory (TCL), the Second Party is engaged in Business, R & D, in the fields of Medical and Healthcare and related fields.

8. Tahbildar Clinical Laboratory (TCL), Mangaldai, the Second Party is promoted by Group of Doctors, Mangaldai, Assam (address & background)

9. Tahbildar Clinical Laboratory (TCL), Mangaldai, the Second Party operates in Mangaldai, Ward No.1, Darrang, Assam (location/branches)

Now, therefore, in consideration of the mutual promises set forth in this MoU, the Parties here to agree as follows:

I. COOPERATION:

1.1 Both Parties are united by common interest and objectives, and they shall establish channels of communication and cooperation that will promote and advance their respective operation within the College and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

1.2 The First Party and Second Party cooperation will facilitate effective utilisation of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching / training systems, keeping in mind the needs of the industry, the Second Party.

1.3 The general terms of operation shall be governed by this MoU. The Parties shall cooperate with each other and shall, as promptly as reasonably practical, enter into all relevant agreements, deeds and documents (the Definitive Documents) as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MoU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

2. SCOPE OF THE MOU:

2.1 The budding graduates from the College could play a key role in technological upgradation, innovation and competitiveness of an industry. Both Parties believe that the close cooperation between the two would be of major benefit to the student community to enhance their skills and knowledge.

2.2 **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching / training methodology and suitably customise the Curriculum so that the students fit into the industrial scenario meaningfully

2.3 **Industrial Training & Visits:** Industry and the College interaction will give an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programmes for the First Party. The Industrial Training and exposure provided to the students and faculty through this association will build confidence and prepare the students to have a smooth transition from academic to working career. The Second Party will provide its Labs / Workshops / Industrial Sites for the hands-on training of the learners enrolled with the First Party.

2.4 **Research and Development:** Both Parties have to carry out the joint research activities in the fields of Medical Lab & Molecular diagnostic tech.

2.5 **Skill Development Programmes:** Second Party to train the students of the First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.

2.6 **Guest Lectures:** Second Party to extend the necessary support to deliver guest lectures to the students of the First Party on the technology trends and in house requirements.

2.7 **Faculty Development Programmes:** Second Party to train the Faculties of the First Party for imparting training as per the industrial requirement considering the National Occupational Standards in concerned sector, if available.

2.8 **Placement of Trained Students:** Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships/jobs; and will facilitate placement for at least 30% of the students. The Second Party will itself absorb at least 5% of the trained students. Provided such students are able to meet the second party's requirements.

2.9 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein.

2.10 There is no financial commitment on the part of TCL, Mangaldai. The First Party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

3. INTELLECTUAL PROPERTY:

3.1 Nothing contained in this MoU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but limited to know how, inventions, patents, copy rights and design) of the other Party.

4. VALIDITY:

4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period Takhildar Clinical Laboratory, the Second Party, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of the Takhildar Clinical Laboratory, Mangaldai, the Second Party after termination of this Agreement by way of communication, correspondence etc. shall not be construed as an extension of this MoU.

4.2 Both Parties may terminate this MoU upon 30 Calendar days' notice in writing. In the event of Termination, both Parties have to discharge their obligations.

5. RELATIONSHIP:

5.1 It is expressly agreed that First Party and the Second Party are acting under this MoU as independent contractors, and the relationship established under this MoU shall not be construed as a partnership. Neither Party is authorised to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other other Party, without the prior consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MoU to make any agreements of any kind in the name of or binding upon the other Party's credit, or to extend credit on behalf of the other Party.

6. NONEXCLUSIVITY

9.1 The relationship of the parties under this MOU shall be nonexclusive and both parties, including their affiliates, subsidiaries and divisions, are free to pursue other agreements or collaborations of any kind. However, on entering into a particular agreement or understanding, the participants may agree to limit each party's rights & responsibilities.

7. ASSIGNMENT

7.1 It is understood by the Parties herein that this MOU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

8. CONFIDENTIALITY

8.1 The parties to this MoU undertake to treat as CONFIDENTIAL AND PRIVILEGED information of the either party. The terms of confidentiality and mode of disclosure shall be as per mutually acceptable terms.

8.2 Except as reasonably required, both the parties covenant that neither the party shall at any time during this MOU or at any time after it is terminated disclose or reveal to any person / organisation or otherwise make use of confidential information including

the trade secrets, confidential operations, processes or dealings or any information concerning the parties and their subsidiaries, business, finances, transactions or affairs of the affiliates / agencies or any of their ventures which may come to the knowledge of either the party during the period.

8.3 During the period of the MOU, each party agrees to respect each others freedom of operation. Neither the parties shall interfere in the affairs / functioning of the other except regarding the successful implementation of the programme.

9. ARBITRATION:

9.1 Any dispute arising with regard to any aspect of this MOU shall be settled through mutual consultations and agreements by the parties to the Agreement.

NOW, THIS DEED WITNESSETH AS FOLLOWS:

1. That the agreement is effective from 09-12-2023 till date to be specified as per discussion later on or at least to that point of time when the first batch of students complete their course and get their certificates.
2. The 1st party is represented by its authorized signatory, namely, Dr. Kamala Kanta Borah, Principal, Mangaldai College, Mangaldoi, Assam.
3. In pursuance to notice/ advertisement in local media by the 1st party, 2nd party has expressed interest to conduct Skill Training Certificate Course abiding by the terms and conditions detailed in the said notice/advertisement in the college campus under joint certification with the 1st party which has been mutually agreed upon.
4. The above mentioned joint certificate to the students who successfully complete the course will be signed, among others, by the authorized signatory of the 1st and 2nd party.
5. The course will be available to bonafide students of the college, preferably from the Degree Classes who apply for the course in prescribed format as devised by the 1st party.
6. The 2nd party will provide the course curriculum, contents and well-qualified faculty (as and when necessary) as per UGC Norms for effective implementation of the course.
7. The 1st party will provide the requisite infrastructure for the course with the condition that the 2nd party shall judiciously use the resources with reasonable care.

8. The evaluation will be done by the 2nd party with competent faculty in a transparent manner with a provision for the 1st party to have a say in disputed matters.

9. The fee will be collected by the 2nd party as per the cost specified and agreeable by both of the parties. The amount collected by the 1st party so far will be transferred to the 2nd party immediately.

10. The certificate will be awarded to eligible students only on completion of course and on payment of the entire due amount.

11. The course will be taken on a regular basis except on College Holidays and on Sunday. The timing must be such that it does not hamper regular college classes and are invariably completed by 3.30 so that even girl students can reach home before dusk.

12. Timing schedules of classes will be made available to all students for an entire week a copy of which must be shared with the Coordinator, VALUE ADDED COURSE COMMITTEE. If the condition of clause 11 above and 12 are not abided by, classes can be suspended by the 1st party without assigning any reason thereof, keeping especially in view the safety and security of the girl's students.

13. Both the parties reserve the right to call off this agreement with a prior notice of 30 (Thirty) working days.

14. If this agreement is called off in any eventuality, both the parties must ensure that there is not any batch of students with incomplete course, certificate or evaluation.

15. The number of batches and students to be trained has to be mutually agreed on and has to be notified by the 1st party.


16. The 2nd party, while reserving its right to include or exclude any faculty, has to invariably ensure that the details of Academic Qualification of all faculties must be as per Clause 6 above and such details must be shared with the Coordinator, VALUE ADDED COURSE COMMITTEE.

17. The 2nd party will provide a certified copy of the course Content the Coordinator, VALUE ADDED COURSE COMMITTEE immediately. Any updating or addition or exclusion to the course contents must be done only with the mutual consent of both the parties.

18. The batches, once initiated, should end within the stipulated time and absence of students for indefinite or uniformed times will not be entertained. Both parties will implement it in letter and spirit.


19. Subject to the demand of the students and 1st Party, the Certificates will be issued by N.S.D.C. Skill India which will be initiated by the 2nd party.



THIS AGREEMENT is made this 30th day of August 2023, by and between:

(i) Mangaldai College having its headquarters at Upahupara, Mangaldoi-784125 Darrang, Assam, hereinafter called the "HEI" or the 'First Party' of the FIRST PART.

(AMTRON), having its registered office at, Industrial Estate, Bamunimaidan, Guwahati- 781021, Assam, hereinafter called "Program Manager" (which expression shall, unless it be repugnant to the context or meaning thereof, mean and include their administrators, successors in business and permitted assigns) or the 'Second Party' of the Other Part

AND

(iii) TEAMLEASE EDTECH LTD., having its registered office at 903, Western Edge II, Western Express Highway, Borivali (E), Mumbai - 400066 and possessing ROC registration number U80301MH2010PTC211390 hereinafter called "Technology Service Provider" (which expression shall, unless it be repugnant to the context or meaning thereof, mean and include their administrators, successors in business and permitted assigns) or the 'Third Party' of the Other Part

Where as

1. The Technology Service Provider is a Company incorporated under the Companies Act, 1 of 1956 and is engaged in the business of providing Education Support services for Educational HEIs and Universities.
2. The HEI is a UGC approved HEI that has endeavoured to launch programmes that will create employable manpower, which is of crucial importance to the economy of the state and the country.
3. The HEI is committed to make learning more effective by application of new technology and innovations.. Further the HEI is committed to provide a wide range of professional and vocational Programs to meet the changing socio-economic needs, with human values and purposeful social responsibility.
4. The Technology Service Provider shall provide its services for all Programs offered by the HEI subject to the terms and conditions hereinafter recorded and agreed to between the parties.
5. The Program Manager shall provide program management for all Programs offered by the HEI subject to the terms and conditions hereinafter recorded and agreed to between the parties.

NOW THEREFORE, IN VIEW OF THE MUTUAL PROMISES AND CONSIDERATION SET OUT HEREIN, the Technology Service Provider and the HEI (each individually a "Party" hereto and collectively the "Parties") have agreed to enter into this Services Agreement ("Agreement") to govern the way in which the Technology Service Provider will provide Academic Support Services to all DA Programs offered by the HEI.

Scope of Agreement

1.1 Scope

This Agreement shall govern the provision of the Employability & Upskilling Services (Apprenticeship/Internship/Trainee/Employee) henceforth known as **Special Services** to Students who are admitted in existing Programs or new Degree Apprenticeship (DA) Programs (Degree, Diploma, Certificate Programs) by the HEI as per the Program Schedule. The Primary Service will include Special Services delivered to the student on behalf of the HEI by the Technology Service Provider & the Program Manager will handle the program management.


The Special Services will be provided to the HEI students in 2 Formats

- **Format A - Special Services for the Final Year Students**
- **Format B - Launch of new Degree Apprenticeship (DA) Programs with Special Services**

The responsibilities of each party are mentioned in **Annexure A**. The complete list of Programs intended to be covered by this Agreement is provided in **Annexure B** to this Agreement. The afore-mentioned list may be modified by mutual consent at any stage as may be required therein. The fees sharing arrangement between the parties is covered in **Annexure C**. The refund policy is covered in **Annexure D** to this agreement.

1.2 Commencement and Duration of this Agreement

This Agreement shall come into effect on the Effective Date and shall continue till the completion of an initial period of Five years. The Agreement may be renewed with written consent of both the parties for a further period unless either of the parties decides otherwise. In case, any one of the parties decides not to continue or renew the Agreement, the party shall be required to give a written notice to the other party of at least 90 days prior to the expiration of this Agreement.

1.3 Approvals and Required Consents

Each Party shall at all times and at its own expense (a) strictly comply with all Applicable Laws, now or hereafter in effect, relating to its performance of this Agreement; (b) pay all fees and other charges required by such Applicable Laws; (c) maintain in full force and effect all licenses, permits, authorizations, registrations and qualification from any Authority to the extent necessary to perform its obligations hereunder; and (d) Cooperate with each other to the fullest extent to fulfill the above mentioned requirements.

Breach & Rectification

In the event that either Party believes that the other is in material breach of its obligations under this Agreement, such aggrieved Party may


- i. Serve a Sixty (60) days' notice for curing this material breach. Any notice served pursuant to this Article shall give reasonable details of the Material Breach.
- ii. If the Material Breach is not rectified within this period of 60 days, the aggrieved Party will have the option to terminate the Agreement immediately.

1.4 Effect of Termination

On the termination of this Agreement as per the effective date aforesaid, the HEI shall stop the use of the Special Services & the Content and shall return the same to the Technology Service Provider forthwith, along with all documentation copies related to the Service. The Technology Service Provider will continue to service all enrolled students and the HEI will provide necessary support such as conducting exams and the issuing of certificates until the successful completion of the Programs they are admitted for as per the agreed-upon terms and conditions as provided therein. The Fee sharing for these set of students shall continue for this remaining extended period as per the Annexure C.

1.5 Dispute Resolution

This Agreement shall be interpreted and construed in accordance with the laws of India. Any dispute or difference whatsoever arising between the parties to this Agreement out of or relating to the construction, meaning, scope, operation or effect of this Agreement or the validity of the breach thereof, which cannot be resolved through mutual discussions, shall be referred to a sole Arbitrator to be appointed by mutual consent of both the parties herein. In the event the Parties are unable to agree on who the sole

arbitrator will be, the dispute shall be finally settled by a sole arbitrator, appointed pursuant to Section 11 of the Arbitration and Conciliation Act, 1996. The provisions of the Arbitration and Conciliation Act, 1996 will be applicable and the award made thereunder shall be final and binding upon the parties hereto, subject to legal remedies available under the law. Such differences shall be deemed to be a submission to arbitration under the Indian Arbitration and Conciliation Act, 1996, or of any modifications, Rules or re-enactments thereof. The Arbitration proceedings will be held at Guwahati, Assam. Each Party shall bear their own costs and expenses, incurred in connection with the arbitration proceedings.

Indemnification

Each Party shall indemnify and hold the other Parties harmless from third-party claims arising from or related to

- a) A breach of the terms of this Agreement; or
- b) A violation of any Applicable Law.

The foregoing is, however, conditional upon the aggrieved party ("**Indemnified Party**") (i) notifying the party in breach ("**Indemnifying Party**") in writing and in detail without undue delay, (ii) authorizing the Indemnifying Party to conduct any judicial proceedings with such third party on its own, and (iii) providing the Indemnifying Party (at the expense of the Indemnifying Party) with any reasonable assistance so that the Indemnifying Party can defend such third party claims.



Neither Party to this Agreement shall be liable to the other for any loss or damage which may be suffered by the other, due (directly/indirectly) to the extent and for the duration of any cause beyond the reasonable control of the Party unable to perform due to ("Force Majeure") events such as but not limited to acts of God not confined to the premises of the Party claiming the Force Majeure, flood, drought, lightning or fire, earthquakes, strike, communal clashes, incidents of violence, lock-outs beyond its control, labour disturbance not caused at the instance of the Party claiming Force Majeure, acts of government or other competent authority, war, terrorist activities, military operations, riots, epidemics, civil commotions etc. No failure, delay or other default of any contractor or sub-contractor to either Party shall entitle such Party to claim Force Majeure under this Article.

The Party seeking to rely on Force Majeure shall promptly, within 2 days, notify the other Party of the occurrence of a Force Majeure event as a condition precedent to the availability of this defense with particulars detailed in writing to the other Party and shall demonstrate that it has and is taking all reasonable measures to mitigate the events of Force Majeure.







Annexure D – Fee Refund Policy

This fee refund policy is applicable only to Format A - Special Services for Existing Students currently enrolled with the HEI (Final Year Only). Fee refund policy for new courses (Format B) shall be decided jointly by the HEI, Program Manager & Technology Service Provider.

Full Refund

- Student will get a full refund in case the Program is cancelled by the HEI or the Technology Service Provider
- Upon withdrawal from the Program by the student prior to the start date of Special Services offered by Technology Service Provider, a student can claim for a refund of 100%
- Student can claim for 100% refund if s/he is not provided with at least 3 On-job training (OJT) opportunities within 90 days from the day of completion of enrolment
- Family can claim for the 100% fee refund in case of any permanent disability or mortality of the student

Partial Refund

In case the student does not qualify for a full refund, a partial refund can be considered subject to the following deductions

- Failure to attend an interview shall draw the following penalty that shall be deducted from the fee paid, while computing the refund amount

RECITALS

Mangaldai College, with over three thousand students enrolled annually, is the pioneer higher educational institute of Darrang district, offering undergraduate degree programmes in the disciplines of Science, Arts, B.Voc, and Technology, and one postgraduate programme, MA in Assamese. Situated on the North bank of mighty Brahmaputra in central Assam, Mangaldai College was established in 1951 by some leading visionary citizens of the district to spread higher education in this backward region of the state. Today, the campus of the college remains vibrant with academic, co-curricular, and extracurricular activities, and various Units and Cells of the college, such as the NCC, NSS, YRC, WSRC, etc., are actively involved in extension activities on their own as well as in collaboration with government agencies and Non-Government Organisations.

Crystal Vision, having its office at Ward No. 1, Mangaldai, Darrang, is an active and dedicated Non-Profit Organisation (NPO) established in 2010 and registered under the Society Registration Act in 2011. Subsequently it was registered under NITI Aayog in the year 2017 and under JJ (Care and Protection of Children) Act, 2015 in the year 2018. Crystal Vision was formed with a crystal-clear objective of extending helping hand towards the weaker section of the society and help the youths' prospect for a prosperous future. The organization has been functioning in various fields of social services including regularly organizing of voluntary blood donation camps, plantation and environment protection, free health and eye screening camps for the under privileged section particularly children, supporting students with merit belonging to financially weaker families, legal awareness on child care and adoption Laws and its modalities and also on free legal aids for children, women, differently able persons, widow, senior citizens and people from below poverty line (BPL), sensitizing students, youths and grass root people about road safety measures, etc. The dedicated, untiring, sincere and selfless service of the organization has already been recognized with the Chief Minister's Best Community Action Award by the Darrang district administration in 2014. Acknowledging the dedicated services of Crystal Vision, the Darrang district administration has included its representative in the District Mineral Foundation Trust, District Public Health Board, District Child Protection Committee and District Inspection and Monitoring Committee under PC&PNDT Act, 1994 among others. Since 2018, the organisation has been running a government-recognised home, namely "Aai", for orphaned, abandoned, and surrendered children below six years of age, which is the only specialised adoption authority of the district under CARA, an autonomous body of the Ministry of Women and Child Development, Govt. of India. So far eleven pairs of registered couples in India and abroad have adopted child taken cared and protected in 'Aai'.

Therefore, in consideration of their mutual interests and the covenants set forth herein, the Parties agree as follows:


ARTICLE 1 **PURPOSE OF THE MoU**
